A. LICENSE: Measurement Equipment Corporation, dba MEC Software grants you a license to use the product included in this package containing computer programs (SOFTWARE) in accordance with the terms of this license. The copyright and all other rights in the software shall remain with us or our suppliers.

B. YOU MAY: Distribute the fonts created with this SOFTWARE as an integral part of software developed by you, limited to the maximum annual average indicated at the top of this license; Make one additional copy of the complete SOFTWARE package for archive or back-up purposes

C. YOU MAY NOT: Distribute or copy any of the fonts except as a part of your software package; Distribute or copy any of the SOFTWARE development files or tools, including the Barcode Font Generator; Rent, sell, lease, assign or transfer the SOFTWARE package or any of its components except as set out above; Transfer this license to someone else.
