**Use of fonts permitted on any number of computers and printers within a single facility owned or operated by the licensee.**

**IMPORTANT:** Carefully read this license before using the enclosed software. Using the software indicates your acknowledgment that you have read this license and agree to its terms. If you do not agree to its terms, return the unopened product within 30 days of the date you acquired it for a full refund. This license agreement is your proof of license. Please treat it as valuable property.

**A. LICENSE:** Measurement Equipment Corporation, dba MEC Software grants you a license to use the product included in this package containing computer programs (SOFTWARE) in accordance with the terms of this license. The copyright and all other rights in the software shall remain with us or our suppliers.

**B. YOU MAY:** Use the Barcode Font Generator program on one computer only; Use the fonts created with the Barcode Font Generator program on computers and printers in accordance with the limitations indicated at the top of this license; Make one additional copy of the complete SOFTWARE package for archive or back-up purposes; Transfer the complete Barcode Font Generator package to someone else only if you assign all rights under this license, cease all use of the Barcode Font Generator and the fonts created with it, remove all copies of the Barcode Font Generator and the fonts created with it from computers and printers, and if the person to whom the package is transferred agrees to the terms of this license.

**C. YOU MAY NOT:** Sell, copy, or otherwise distribute the Barcode Font Generator program or any of the fonts created with it to other parties; Use the fonts outside the limitations indicated at the top of this license; Rent, sell, lease, assign or transfer the SOFTWARE package or any of its components except as set out above; Modify the fonts or merge all or any part of this package or the fonts created with it into another software product.

**D. TERMS:** This license shall continue for as long as you use the product. However, it will terminate if you fail to comply with any of its terms or conditions. You agree, upon termination, to destroy all copies of the Barcode Font Generator and the fonts created with it.

**E. WARRANTY:** We warrant that the storage media for the SOFTWARE will be free from defects in materials and workmanship for 90 days from the date you acquire it. If such a defect occurs, return the product to the address below and we will replace it for free. We warrant that the SOFTWARE and its use do not infringe upon any copyright, patent, trade secret or other proprietary or intellectual property right of any third party, and that there are no suits or proceedings, pending or threatened alleging any such infringement. The Licensee shall inform us of any suit or proceeding filed against Licensee and shall have the right, but not the obligation, to participate in the defense of any such suit or proceeding at Licensee's expense. In the event of a breach of this warranty MEC shall, at its option and expense, either (I) procure for the Licensee the right to continue to use the Software as set forth in this Agreement, or (II) modify the Software to make its use non-infringing while being capable of performing the same function without degradation of performance. If options (I) and (II) are not feasible, MEC shall grant Licensee a full cash refund for the Software, and Licensee shall return or destroy (or have returned or have destroyed) any available copies of the Software, fonts produced by the Software, and Documentation.

**F.
